Superintendent Petersen reported that the Swedish Clinic space will be available beginning on December 1, 2017 for any modifications necessary prior to moving KVH Urgent Care to that location. On February 1 the space previously occupied by KVH Urgent Care will be available in the Cle Elum clinic building for Swedish to house specialty services.

Superintendent Petersen reported that she and two District 1 Commissioners attended Rural Advocacy Days in Washington, D.C. where they requested continued support for the rural add on payment for rural ambulance services.

Superintendent Petersen updated the Commissioners on changes in rehabilitation services in Ellensburg and pharmacy initiative in Cle Elum.
